The Ministry of Finance - General Secretariat of Fiscal Policy is pleased to announce that authorizes the Bank of Greece to dispense to the public the €6 silver collector coin dedicated to: “2022 – INTERNATIONAL YEAR OF ARTISANAL FISHERIES AND AQUACULTURE”



- The **date of release** is set to be the **11/10/2022**
- The **selling price** is **36.29€** per coin plus V.A.T. (45,00€)
- The maximum mintage is **2,000 coins**

\*\* Applicants should send a letter of request to the Directorate of State Guarantees and Capital Transfers of the Ministry of Finance, via e-mail ([d25numismaticorders@glk.gr](mailto:d25numismaticorders@glk.gr)), from **19/9/2022 until 21/9/2022**. Only within this time span will reasoned letters for change/cancellation of the initial quantity requested be accepted. The request must be accompanied with a receipt of 50% deposit of the value of the order, in the account of the Bank of Greece (IBAN: GR 2701 00052 00000000 59134368, BIC: BNGRGRAA), with the indication {DEPOSIT FOR THE PURCHASE OF THE NUMISMATIC PRODUCT "2022 – INTERNATIONAL YEAR OF ARTISANAL FISHERIES AND AQUACULTURE"}. Requests for cancellation or modification are accepted during the same period. In case of cancellation, 25% of the deposit is withheld in favor of the Greek State, whereas a 15% in case of modification. In case of fulfilling the initial order in total, a 6% discount is provided on the remaining 50% cost of the order.

Requests will be approved in priority, according to the time they are sent to the electronic address mentioned above. In case there is no more quantity left, the applicants are informed about their unapproved request and the deposits are returned in total via the Bank of Greece, within a reasonable time period and in any case no longer than twenty (20) working days.

Finally, all details regarding the issue and dispensation of the forthcoming numismatic products will be announced with further press releases.
